

**EMBASSY OF SPAIN STUDENT VISA REQUIREMENTS**

<b>STUDENT VISA- CODE SLU (More than 180 days)</b>		Y	N
1	<b>National Visa Application Form</b> , dully completed and signed by the applicant. For minors, both parents or legal guardians must sign.		
2	<b>One passport size photograph</b> with white background, pasted on the form with glue (do not staple), taken within the last three months. For Man, the head must be uncovered, for woman, the full face must be visible down to the hairline.		
3	<b>Original passport:</b> signed by the holder, valid for at least 1 year and a clear copy of the biographic page.		
4	<b>Qatar Residence Permit</b> or <b>National Qatar ID</b> , plus a clear photocopy of both sides		
5	<b>Police Clearance Certificate</b> from the country or countries you have lived for the past five (5) years. This document must be issued by the National Police Authorities of the respective country of residence. It must be attested by MOFA in the country of issuance or Apostilled and translated into Spanish. <b>This requirement is not applicable for minors unless turning 18 in less than a year.</b>		
6	<b>Medical Certificate:</b> It <b>must be</b> issued in the following terms "This health certificate states that Mr. /Ms. (.....) does not suffer from any of the diseases that may have serious public health repercussions in accordance with what is stipulated by the International Health Regulations of 2005". The medical certificate must be attested or apostilled, this requirement is applicable to all applicants including minors. This document can be issued by Medical Commission Department or Approved Private Hospitals.		
7	<b>Health Insurance:</b> must be valid for one (1) year, fully paid for the whole period, under the name of the applicant, with a minimum international coverage of €30,000, must include a repatriation clause in case of death. <b>The insurance Coverage must be for Residence in Spain not Tourism.</b>		
8	<b>Documents from a recognized School or University in Spain</b>		
	Letter of acceptance, stating number of hours of attendance per week (at least 20h) and the period of studies (In Spanish)		
	Contents of the study or Investigation program in Spanish		
	Proof of tuition payment		
9	<b>Financial Information</b>		
	Applicant must submit an explanatory letter addressed to the Consulate, describing in detail all Financial Information (Bank's name, type of accounts, incomes and final balances must be written and explained in detail in the letter). This explanation is very important, financial situation and budget is vital for the application (enough financial means to cover all expenses during the intended period of Residence in Spain must be proven) attach original evidence of every aspect mentioned on it		
	<b>If the person in charge of the expenses is not the applicant</b> , the letter mentioned above must be written with the title " <b>Sponsoring letter</b> " for the student. In this case, passport copy, QID and salary certificate or any other income or investments of the sponsor must be attached. The letter must be signed and translated into Spanish.		
	<b>Original Bank statements</b> for the last six months from the submission date, with the name of the Owner in English.		
	<b>In case it is a scholarship</b> , original offer letter stating which financial aid will be provided is required.		
10	<b>Students below 18 Years old, must also provide:</b>		
	Photocopy of the identification documents of the person who will be living with the minor in Spain (Passport and DNI or TIE).		
	Authorization letter from that person to consult in the Registry of Sexual Crimes. This is not applicable for relatives or members of an education institution.		
	<b>Power Of Attorney:</b>		

**All the above documents must be translated into Spanish, except the Bank Statements.**

Declaration: I understand that due to recent changes in the Spanish regulations, the visa application process will not take less than 2 months and that the decision on whether to issue a visa is at the solely description of the Embassy of Spain. I have been informed that an application with incomplete set of documentation according to the above checklist may result in the refusal of a visa. I may be requested for a personal interview or to provide additional documentation.
